State elections will take place in Baden-Württemberg on 8 March 2026

The AfD (Alternative for Germany) has been in the Baden-Württemberg state parliament since 2016. **17** of the 154 parliament members belong to the AfD. **They make no secret of their contempt for democracy and the rule of law.**

We can all help make sure that the AfD lose their seats in parliament.



The GRANNIES AGAINST THE FAR RIGHT want

■ **Human Rights for All**

“Human dignity is inviolable...” is stated in Article 1 of the German Constitution.

At demonstrations, party conferences and also in parliament, AfD politicians insult minorities and demand that their rights be restricted.

- In the Bundestag (German federal parliament), the AfD has appealed for the abolition of same-sex marriage. (1)
- The AfD rejects the communal teaching of children with and without disabilities. (2)

- The AfD wants to impose drastic restrictions on asylum rights. (3)

■ **Social Justice**

In its federal election manifesto, the AfD promised tax reductions. (4)

This would primarily benefit the rich.

The ZEW Leibniz Centre for European Economic Research in Mannheim calculates: (5)

- **A single-earner family with two children and an annual gross income of Euro 180,000 would be Euro 19,185 better off annually.**
- **A single-earner family with two children and an annual gross income of Euro 40,000 would be Euro 443 worse off each year than previously.**
- **The AfD wants to reduce social security benefits and abolish social housing.**

■ **Internal Security**

In May 2025 the Federal Office for Protection of the Constitution officially classified the AfD as “right-wing extremists”.

The party has lodged an appeal – until a decision is made, it will continue to be treated as suspect. (6)

- **Hatred and incitement are proven to lead to an increase in extreme right-wing violence.**
- **In 2024 the Federal Criminal Police Office recorded 1488 cases of extreme right-wing violence, 17 per cent more than in 2023.**
- **The total number of extreme right-wing criminal offences in Germany increased by 48 per cent to 42,788. This equals 117 cases each day. (7)**

■ **A Liveable Environment**

The AfD denies that mankind is responsible for climate change.

In July 2025, the party in parliament appealed for the abolition of climate protection laws and the cancellation of international agreements. (8)

- **They advocate a return to nuclear power.**
- **They reject renewable energy.**
- **They want to cancel investment in climate protection.**
